6.1 Managing Director

TG mentions that:

- Student numbers on campus has significantly increased, and it is a good sign for the Guild.
- The 2022 SSAF spending reports are up on the website now.
- There has been no update on the WA University Review yet.
- Masterplan project is still in progress. He mentions that GJ, VVM and himself presented the project to the UWA Senate, who welcome the project and shared a common consensus of how important this project is for the student body and the campus in general. He commends the work put in by GJ and VVM, for this project thus far. He further mentions that the Guild will be meeting with the University Executive in the next couple of weeks to discuss the financing of the project.
- The Guild will start looking at the relevant logistics of starting the construction of the Guild Precinct in the next few weeks.
- Minister Tony Buti visited the Guild and had very fruitful conversations around the Masterplans and Welfare issues.
- 2022 Annual report has been delayed as the administration is waiting for few more reports to come through.
- The Catering Review report is expected to come at the end of the month.

- In the month of July, the Guild made a loss of \$68859, this is slightly over budget she mentions. This is primarily because of timing differences.

9. QUESTIONS TIME - Student Reports

LA asks;

- MDA to elaborate the 2 events she has been working on with Amnesty International club.MDA explains that she and the club is working on a human rights act. They planning on an information panel at the end of the semester.
- MDA to give an update on her role as the NUS WA ED VP.MDA replies, saying she is happy to give a written report to LA later on and not a verbal reply to the question as she is present at the meeting as an OGC of the Guild.
- RW to give an update on Relay 4 Life.RW replies, saying that he had to take over the role of Chair of R4L couple of weeks ago, since there were talks of it being cancelled as there was no progress made on the project by the then committee. RW has met with Cancer Council multiple times and now they have agreed helped the Guild with the event. He mentions that the Clubs, Colleges and FACSOCs have been informed of the date and venue (7-8th of October 2023 @ Rliey Oval) via the relevant Sub-Councils.
- AL to give an update on her project of increasing international student scholarships. AL replies, saying that the initial contact she had from the university on the matter has said to her that this is not her portfolio anymore. Hence, she is in the process of trying to get a contact that overlooks this portfolio.
- IC why the Tav Show last Sunday was cancelled. She replies saying the timing of the event was not correct since there were a lot of assignments during the time for students. She further mentions that since Tav Wednesday have been successful in the last few months, and considering majority of the attendees are the college row students, residents are not very keen to come to the Tav for an event twice the same week. Looking at all these reasons, the RSD Committee decided that it is financially viable to cancel the event.

MDA asks a question asks about the relationship between the publications committee and Udub Radio.

Council gives CJ speaking rights.

CJ replies saying that the Udub Radio Director does not sit on the publication committee. But he suggests that this should be a conversation for the Guild President and the Publication Committee should have moving forward.

IC asks why there is no content nor updates on projects on the Ethnocultural Co-officers' reports. AN reply saying that she will take it back to the Co-Officer and hopefully will have a response for it next council meeting.

IC asks MDA, that MDA mentioned either in the June/July that she has the submissions made by the other WA Guilds to the WA University Review Panel and said she would share those submissions with the rest of the Guild Councils. MDA replies, that she shared the Murdoch Guild's submission with VVM, however she hasn't received the ECU and the Curtin Guild's submission.

TU also adds that NSSS survey recommended that it is important campus grounds should be safe with more CCTV cameras and lighting in place and it is great that we are taking a proactive approach in the matter.

AM speaks against the motions. He mentions that the University can use this data against students later on.

IC speaks for the motions. She mentions that the NSSS survey reports that most student complaints were made in dark areas without proper lighting or security.

TU speaks for the motions. She mentions that CCTV cameras help students to get access to physical evidence if needed as most times student reports on sexual harm goes unnoticed as there is no proper evidence.

AJ speaks for the motion and shares similar consensus.

- 15.2.5. Opposes the anti-abortion meeting held by the Australian Christian Lobby and the Coalition for the Defence of Human Life, which intends to try and block the current reforms
