External | Parking

Many of you may have seen some media about parking at UWA over the past few weeks. Parking for students has increased this year in line with CPI and there are no immediate plans to increase parking in the short term. I have been in contact with the University Executive and they have been made well aware of the issues relating to students and the cost of parking. They have given a reassurance that the Guild will be consulted should any changes to the cost and policy on student parking be made. Your student elected councillors at the Guild will actively monitor this matter throughout the year and be in constant dialogue with the University.

Activities | PROSH

PROSH will be undergoing some indigenous sensitivity training in response to recommendations made by the review of PROSH in 2013. I would like anyone who would also like to attend the training along with the director, editors and writers for this year to participate. It will look good to the university and you may even learn something.

Activities | Grill the Guild

We will be conducting Grill the Guilds at each of the colleges. I would like a very strong attendance from Guild councillors. There are Facebook events being added to the 101st Guild councillor page this week. If you can attend please indicate that clearly as we will need as much help as possible.

Activities | Enrolments Orientation Survey

We will be releasing an orientation survey for all students so we can evaluate the response of students to the changes to the orientation program in 2014. We wish to do this survey independently to student services so we can use the information to create a plan for 2015. When this is released, please promote it amongst your networks so we can get a reasonable response rate.

University Relations | English Conversational classes

The English Conversational classes between the Volunteering Hub and the Centre for English Learning and Teaching is underway and will have a draft ready for the next Guild Council. We have a large amount of support from each of the groups we just need to put a formal proposal in front of each stakeholders to formalise the agreement.

University Relations | WIFI/IT/IM

The University in the SIMTIC meeting had significant discussion about the need to improve the infrastructure to supplement the student experience. The University is currently looking at the most efficient way to spend the funding in the IT and IM arena. They are putting together a significant proposal together which will supplement the office of organisational excellence.

There are more access points going in around Reid so the speed and quality of those connections should improve.

In the same meeting they have increased the Reid reserve to 3 hrs.

University | NTEU Industrial Action

The NTEU have successfully balloted their members and have begun industrial action at the university. Currently they have planned for

- Limitations on working overtime and enforcements of payment methods of overtime and TOIL;
- Limitations on and refusals to participate in the PAR and PDR processes;
- Bans and partial bans on assisting students in enrolment processes.

We have been in negotiations with the university and the NTEU and are assured the only effect on student at the moment is that of assisting enrolment of students, which the majority has already been completed. The University has planned to withhold payment of any staff member hindering the enrolment process of students and as such there is unlikely to be many staff participating in this form of strike.

MASA

- Three meetings with MASA committee to organise for the year ahead.
- MASA logo complete and in use, thanks Kate.
- MASA Welcome Lunch- 18/3. Sue Boyd Room. Around 40 attendees. Mature Age Access Programme also sent a representative.
- Committee reduced to 3 members (not including myself), as one was not a UWA student.
- Currently advertising for more committee members to spread workload.
- Committee are slightly worried about being able to spread their budget across intended number of events (8), but I have advised them to consider charging a nominal fee for more substantial events (i.e. sundowner at Uni Club) etc.
- UniPrint account being setup for MASA.

Parking Appeals Board

- Attended two Parking Appeals meetings (they occur fortnightly during semester).
- Waived lots of fines (around 80% in the second meeting).
- Generally able to waive anything with obvious mitigating circumstances, but silly excuses or "I was running late" usually result in a failed appeal.

Departments

Working to set up an informal department OB meet-up.

CSC

- IT plans update. Briefing / requirements doc to be prepared and sent out to potential service providers outside of UWA. Using UWA's service may be too expensive. Options include college providers and Amazon. Also consideration to use Google Apps vs Exchange etc.
- External email aliases for clubs- in progress, awaiting time assessment from IT.
 Non-preferred option so will not be advertised generally.

- Online ticketing with Trybooking to be offered by Finance / Events as a club service.
 Currently working on internal management policy. Finance are able to process, we can offer access to a report-view-only Trybooking portal for student events. Great result for clubs with no external bank account.
- Loan recovery policy examined from finance perspective (reducing outstanding overdue loans). Requesting an update to the policy set out by Welfare and Advocacy to more clearly set out overdue loan follow-up procedures.

IT Projects

- Soc/Events progress work in progress. Kaila is all over the design stage. I've been inputting a few structural ideas to keep all these IT projects fitting in the same ecosystem.
- Guild website progress currently loading content. Testing to follow. Launch in a few weeks. Get in touch if you have content for the site.
- G-News. Met with Alex, Tony and Vishal to set out a plan for new G-News. Plan includes
 much more succinct newsletter, companion website (gnews.com.au or similar). Look for
 this in the next few weeks. Closely tied to the new website.
- Paypal. The Guild has a Paypal account. We'll be launching online payments for various things (firstly associate memberships) soon after the website launch. From there... internal event payments, O-Day stalls... the sky's the limit.
- Social media post request form. To reduce staff back-and-forth for simple post requests.
 All requests must be received via www.bit.ly/guildsocialmedia.
- Design/memberships ticket system. Trialling a ticket system in Design and Memberships. Emails to designrequest@guild.uwa.edu.au are now allocated a ticket (similar to IT support tickets). Outcomes: easier to track than email conversations, canned responses for common requests, tracking of "projects", easier allocation of tasks between teams, ability to track employee response times / work load etc.

Over the last month, much of my time has been spent promoting Guild events and services, and working with different Guild departments, student reps and staff.

Back To Uni Party was successfully promoted - possibly too well! I'm very pleased that so much hype could be built up for a Guild event! There are definitely things that can be improved on next time, such as the security and organising the queues to the venue, but I believe that everyone who went in had a great time. Boston Switch and Peking Duk both told me that they were impressed with the festival-style set-up and that they thought the night was great! Thanks are due to the events team and to all the staff and students who helped on the night. Over the last couple of weeks, I have also attended and helped out at various Guild events such as Club Carnival, Guild Volunteering Joint Venture Launch and PAC Slam Poetry, which I ended up MC'ing. I was on the door with some other student reps for the whole day and it was good to see the Scantechs implemented. The following day was the Guild President's XI vs. Vice Chancellor's XI Cricket Match, which we won! The day ran smoothly, but next year it'd be great to work on getting a bigger turn out from students and other spectators!

Two Student Services Committee Meetings have been held since my last report and the committee has covered Student Assist, Volunteering, Events and Memberships & Communications. Some really positive ideas have come out regarding how we may promote Student Assist and Guild Volunteering, as well as some fantastic ideas for events. I have also met up with a few others to kick off the Guild's Marketing Strategy - which has focused on how we will engage students and how we will market Guild services and events. Hopefully this 'working party' will help to increase students' awareness of the Guild. As part of this, Maddie and I organised 'lecture bashes' for the large first year units, where we told the students about the services Guild offers. While we were unable to attend all of the lectures that we had planned to, we spoke in front of hundreds of new students and we received positive feedback!

Over the past week, I have been busy organising the Guild Ordinary Committee Member Positions nomination process. The positions were advertised on the Guild Facebook page, in G-News and on the website, and as a result there has been quite a bit of interest from students! Catering and Tavern | Catering

We have sourced the board games to be delivered to Hacket Café. It will cost \$504, which will be absorbed within the Catering accounts.

Reports from the Refectory regarding Frozen Yoghurt and Burritos have been very positive. Around 40 units of frozen yoghurt and burritos are being sold on average and the demand continues to grow. We are also looking into the possibility of introducing T2 into the Refectory as well as serving tea in ceramic crockery to create the desired ambience.

Formal orders have been placed for the new equipment in Reid café in relation to the refurbishments. The refurbishments will be done over the weekend with minimal impact on use during student hours.

Discussions were also had about the special dietary requirements on campus. Although we have accommodated for everyone, there appears to be a lack of knowledge about these services and we are looking to promote this to students.

Catering and Tavern | Tavern

Jugs of Pimms are now available in the Tavern, with a jug priced at \$20.

Treasurer | Budget

I have been in consultation with our management accountant to discuss the accounts for January. Looking at the January results, all Guild departments are on or under budget. A large part of this is because January does not have much student activity. February accounts are yet to be finalised.



Ed Council President Report | March 2014

CLUBS |

I am currently working with Tom Beyer (Arts Union Ed VP) to encourage clubs that are related to the Arts Faculty to take an interested in education issues, and to form collaborative relationships with the Arts Union. After the success of Science Union's President's Forum, we are hopeful that a similar initiative will involve a larger group of students in education advocacy and highlight a broader range of education issues, and in doing so ensure that these problems are fed back up to the Arts Union and Education Council. This has been going really well so far.

EDUCATION ACTION NETWORK AND NATIONAL DAY OF PROTEST |

The EAN is being relaunched with a fresh and approachable/inclusive face (both metaphorically and actually, care of Oscar Morlet and his face). At the time of this report, the EAN Relaunch will be taking place on the 25th of March — we will be giving students information about cuts to Higher Education, what's happening with education at UWA, painting a banner and placards for the rally and taking photos of people with their placards. There will be a BBQ/activities on Oak Lawn on the 26th before going down the NDA rally in the city. I will give an update at the meeting on how these events went, and we will hopefully have some staff getting involved too.

EDUCATION STUDENTS |

I have organised a social BBQ with the Education Faculty for Friday the 28th of March. This is a collaborative initiative between the Faculty and the Guild – allowing students and staff to socialise, and also encouraging them to get involved in an Education Students Committee (as Education Union has been lapsed for a long time). One of the reasons why the Faculty has taken an interest in running social events is due to the lack of a student organizing body. I am hopeful that we can engage students in the idea of getting involved with this Committee, in the hope that we can start Education Union up properly next year.

LCS FAILURE |

There were critical failures with LCS on the 12th and 13th of March. I have discussed this issue with both Alec Cameron (DVC Education) and Grady Venville (Dean of Coursework Studies) and they were both already very concerned with this failure, and agreed that a failure like this is both highly inconvenient for students, and unacceptable of a University service. Particular reference was made to Albany students who only have access to their lectures via LCS. Alec will hopefully be advising staff that it is recommended that they try to upload a previous year's lecture if the content is relevant and the recording is available, or to make additional notes available. I will be following this up with Alec to see whether the staff were advised of this recommendation.

SURF RESULTS |

The release of SURF Results has successfully passed through Academic Board (meaning it has now been endorsed by Teaching and Learning, Academic Board and Academic Council). This is a huge win for students, and will mean that we now have a complete loop for this feedback that students provide. This draws upon the idea that students are 'responsible co-developers' of their education experience, will hopefully increase the response rate for students participating in SURF, and will mean that students have a reliable source of information with regards to unit quality rather than using social media and

alternative sources when evaluating their unit/elective selection. This same information will be made available to UWA Staff, and this practice is consistent across most universities in Australia. The information shared will be the question relating to the overall experience of the unit. It was highlighted at Academic Board that the questions could do with a lot of work, and I am very interested in working with both students and staff in developing better survey questions that allow for an accurate representation of both teaching quality and student experience. I have attached the SURF distribution policy for reference.

Governance

University Policy on: Students' Unit Reflective Feedback (SURF) Survey Data and its Dissemination

Purpose of the policy and summary of issues it addresses

This policy outlines the Students' Unit Reflective Feedback (SURF) on-line survey tool and clarifies the principles that guide the dissemination of SURF evaluation data at the University of Western Australia.

Definitions

the University means The University of Western Australia

Policy statement

1. SURF Survey Tool

- 1.1 Students evaluate their units via the on-line SURF survey towards the end of every semester or teaching period.
- 1.2 The six-item questionnaire asks students to express disagreement/agreement on a four point scale with the following statements:
- 1.2.1 It was clear what I was expected to learn in this unit
- 1.2.2 The assessment requirements were clearly stated
- 1.2.3 The assessment tasks were closely linked to the unit objectives
- 1.2.4 The unit was well organised
- 1.2.5 The learning resources (handouts, text, web resources, etc) were adequate for my study in the unit
- 1.2.6 Overall this unit was a good educational experience
- 1.3 SURF results are stored on a secure database at www.surf.uwa.edu.au
- 1.4 SURF is administered by the Institutional Research Unit.

2. General Principles for the Dissemination of SURF Data

- 2.1 The University relies heavily on SURF surveys as a reliable source of information on the quality of the learning experiences within units.
- 2.2 Given that students are asked to provide evaluative survey feedback via SURF in respect of every unit in which they enrol, it is reasonable and respectful for the University to report back to students on the results of those surveys, and any consequential actions taken.
- 2.3 The University views students as responsible co-developers of their educational experiences.
- 2.4 The reliability of SURF survey data is crucially dependent on a good response rate. Providing students with the results of unit evaluation surveys will encourage them to participate more actively and responsibly in the evaluation of units.
- 2.5 Information on unit quality is widely shared between students on social media, in alternative handbooks and by word-of-mouth and often used in making unit selections. Making SURF survey results broadly available to students will increase the likelihood that their unit selection decisions are based on reliable sources of data.
- 2.6 Any unit evaluation information that is provided to students must also be made available to all academic staff.
- 2.7 SURF results at the individual unit level are reported only to University students and staff.

To be formulated by the Institutional Research Unit in consultation with the Senior Deputy Vice-Chancellor and Faculty Deans.

Public Affairs Council Report

Introduction:

March has been a fast paced month for the Public Affairs Council. We've launched a new series of events this year, which hopefully will be reoccurring in the years to come. Engaging students through alternative, cultural and artistic avenues has been a major goal for PAC, and we feel that our Summer Nights Festival installments have been a huge success thus far.

Some other goals we have been working towards are our external grants applications and establishing advertisement opportunities through CAMPUScreen. We have submitted our first initial application to the Alumni Grants, and consequently have drafted a framework in which we will use to apply for other groups. Pending on the success of our first grant application, the framework may be subject to modification.

There have been no newly affiliated PAC clubs since our last meeting. Treasurer Training was a huge success, thanks to the collaboration between the Societies and Public Affairs Council.

Activities I Summary

Events:

Summer Nights Festival:

- Outdoor Blanket Fort Movie Screening (06/03/14)
 - Application to attaining screening rights for 'Spirited Away' was redireted to Madman Films.
 - Fee also took into account ticketing price as we charged \$2 for Guild Members, \$5 for non-Guild Members
 - Screen was hired externally through StarWest
 - We had a turnout of approximately 60-70 students, many of which were first year and anime enthusiasts
- Recommendations:
 - Starwest are able to attain licensing for public viewings through their company. They have a list of pre-approved films that have an approval turn around period of 24 hours.
 - Continue screening at venues such as Prescott Court as the intimate space is easier to contain sound and lighting quality.
- SLAM Poetry Performance (13/03/14)
 - Students and members of the Community were encouraged to sign up to perform.
 - We were in contact with members from the Perth Poetry Society. They were an invaluable resource in establishing contact with local artists who were very eager to perform.
 - Guest Speaker was an established performer with lots of competition experience. She was a great form of entertainment, and gave a very polished performance.
 - New Fortune Theatre was booked. It was an amazing space with great acoustics for this type of event.
 - We charged \$2 for Guild Members, \$5 for non-Guild Members.

Public Affairs Council Report

- Prizes (cash) were sponsored by Perth Poetry Society.
- Recommendations:
 - Continue utilising New Fortune Theatre as a performance space.
 - Advertise via posters
 - Provide Plaque/Trophy for annual winner to have claim to
- Music On The Green (20/03/14)
 - Outdoor music mini festival is scheduled to go ahead for March 20th.
 - Stage was sourced from ADAsounds, Tech gear sourced from Party West.
 - Performers are all local, each group involving at least one past or present UWA student.
- Recommendations:
 - (Event is yet to occur)
 - Source tech and stage hire crew from previously hired group. Safety Inductino must be completed prior to work. ADAsounds and Starwest will now have valid certification to work on UWA for the next 3 years.
- Social Justice Collaboration are well under way with plans for Social Justice Week.
 - They plan on hosting daily activities on campus (incl. ALVA and QEII).
 - Thrift Shop Party has been organised in the Tav for April 3rd. Proceeds of tickets and clothing collected will be donated to youth shelters
 - Quiz Night will be sponsored by Teach For Australia and Guild Clubs
 - Clubs involved are instructed to send a rep to EACH meeting. A new constitution will be drafted by Chair, Alex Hamilton, which will outline penalties and sanctions to clubs who do not comply to attendances and contribution expectations.

Finances I Summary

- PAC Treasurer, Dana, addressed the allocations of Semester 1 Collaborative Grants.
 PAC clubs planning events in collaboration with other PAC/SOC/Facsoc clubs will be eligible to apply for two \$250 grants, and one \$500 grants. Applications are due by close of business 18th April.
- PAC/SOC treasurer training was a successful and useful tool for new club executives to be introduced to good financial management behaviors. They were also given a run down on online media and advertising strategies.
- Alumni of UWA Grant application was submitted by the dead line as is currently under consideration.
- Advised to post-pone sending in the application for Lotterywest as Incorporated Groups are only allowed to submit one application.
 - We are working with Tony and Jess to formulate an appropriate approach to ensure that each department is aware of available grants.
- Total revenue made via ticket sales to Summer Nights Festivals so far is approximately \$256
- We have gone over initial estimates and allocations for the events, so we will be reviewing at next committee meeting.
 - If unsuccessful with grants applications for Semester 2 activities, we will approach the mid-year budget review for reconsideration of the annual PAC budget allocation.

Introduction

February and March are always the biggest months in the Guild, and this year is no different. Clubs have been very active so far this semester, with an impressive amount of EMP's submitted!

SOCIETIES COUNCIL | SOC Meetings

We held the second SOC meeting on Wed 12th March, which featured Poster Training, Marketing and Social Media Training. Following the meeting we held Treasurer Training for SOC and PAC clubs, and FacSocs were invited to attend. It was structured in a collaborative workshop style. The SOC Treasurer, Rowan, received good feedback on the new structure.

We conducted a Start of 2014 Feedback Survey. We're in the process of compiling the responses and acting on recommendations.

We had one successful new club affiliate – the Student Managed Investment Find. We clarified the EMP process and Food Permit process. We have opened mailbox applications. The next meeting, 16th April, will be the Semester One President's Summit.

SOCIETIES COUNCIL | SOC Grants

The SOC and PAC committees have now approved two sets of SOC grants – Orientation Event Support Grants, and O-Day Sign-Up Grants.

The successful clubs receiving Orientation Event Support Grants were:

Leisure, Undergraduate Physics Society, B-Phil, FAWA, UWA Debating Union, Engineers with Borders, Enactus, Unigames, DanceUWA, MOPSS, UWAnime, Korean Culture Club, Multi-Cultural Student Union, and A.S.I.A.

Some grants received were rejected at the discretion of the committees.

The grant application period has now closed, and the grant process has been fully completed.

O-Day Sign-Up Grants were being finalised at the time of writing this report. They should be distributed shortly.

SOCIETIES COUNCIL | UWA Alumni Grant

The UWA Alumni Grants were open for application to SOC and PAC clubs, FacSocs and the Guild itself, for first round submissions. Lizzy and I received information about this grant pool, and forwarded it to clubs and FacSocs. However, the notice period was not very long — I have only received notification from one club of application. Hopefully clubs will have the time to develop their applications for the second round submissions. Lizzy and I have volunteered ourselves to help review club applications.

SOCIETIES COUNCIL | Club Carnival

Club Carnival was held during Common Lunch Hour on Tuesday of Week Two. A great event, with over 60 clubs attending, and each were provided with a table and two chairs. The aim of the event was for promotion and awareness of the clubs available at UWA, and to reach out to second year students and above, who typically do not attend O-Day. There was good

Election Regulation Reforms

At the January 21st meeting of the Governance Committee, changes to the election reforms were discussed. The Committee focused on improving the administrative side of the election, while the issue of amending the offences and online campaigning rules were also areas highlighted for review.

Since that discussion I have been in contact with Wayne Nicholson (the head of non-parliamentary elections at the WAEC) and Ron Camp (the Returning Officer at the last few Guild Elections). Aiden and I met with Mr. Nicholson and the acting WAEC Commissioner to discuss changes to the regulations, float ideas and to ensure clear lines of communication between the Guild and the WAEC. I found the meeting to be very productive and thought provoking.

I also met with Mr. Camp to discuss the changes, as well as to discuss some of the suggestions raised at the meeting with the WAEC. Mr. Camp's knowledge of the on the ground operations of the election were very informative and I hope to be able to incorporate many of his ideas and suggestions. Interestingly Mr. Camp provided a different perspective on a number of the WAEC's suggestions and has given me plenty to think about

PROJECT STATUS - INITIAL DRAFTING

Discipline Regulations/Policy

When the new Guild Regulations were presented to the Senate, they contained new regulations relating to discipline procedures. These regulations were not passed by the Senate, while the rest were. I am currently in the process of finding out exactly what the current status of those regulations are and what may need to be done to them in order to secure their passage through the University Senate.

I have emailed Gina Barron (Head of the conflict resolution unit at UWA) to arrange a meeting. I have received a reply, however Ms. Barron is currently getting up to date with the changes, and I will be in touch with her again shorty.

PROJECT STATUS - ON HOLD

Standing Orders

The changes to the standing orders were approved by the Governance Committee and were passed by Guild Council at the January Meeting. Additionally changes were made in response to the January meeting at the February Meeting, and these changes have been added to the copy of the standing orders in the Statute Book. While the standing orders should always be under assessment for how they are working, this crux of this project has been completed.

PROJECT STATUS - COMPLETED

Welfare Department Rules/Education Council Rules

Both sets of rules were passed by Governance Committee after being put to it by the respective body. A Minor amendment was made to the Education Council Rules before passage, which made sure the EAN Co-ordinator had to be approved by the Ed Council as a whole. Both sets of Rules passed Guild Council at the January Meeting. These projects have now been completed from a Governance Committee perspective.

The media policy project is currently in its second draft and currently undergoing consultation. The draft is based on current conventions as well as the UWA Media Policy and the University of Adelaide Union's Media Policy. Councillors have been emailed this draft and have been asked for their feedback. This project is on-going and the estimated completion time is the February Guild Council Meeting.

PROJECT STATUS – REVISIONS AND CONSULTATION

Guild Statute Book

The Guild Statute book is currently up-to-date and reflects all changes made at the January Guild Council Meeting. The introduction to the statute book has been slightly updated to reflect the changes.

I had a meeting with Wayne and Karen to discuss the maintenance of the Statute book, both this year and into the future. We discussed measures to keep the book safe, as well as who holds responsibility for the ongoing maintenance of the book. Also discussed was storage/distribution of an online version of the statute book. It was resolved that that Statute Book will be updated by the Chair, however the Admin BSO will be responsible for oversight to make sure the process is completed. However, in light of recent events, this responsibility will need to be moved and I will be having a meeting with Wayne soon in order to determine these matters. Additionally the Guild Website will now carry the entire Statute Book for the ease of students and Guild Personnel, as well as to ensure greater accountability to the students we represent. The Statute Book will now be stored in the Finance Office, and will be available for use via a sign-in sign-out system.

PROJECT STATUS - ONGOING

Guild Policy Book

I am currently compiling every policy I can into a single policy book which will hopefully be made available online (through the Guild Website). Most policies are actually rules of the Guild and thus need to be included in the Statute book, so this project ties in well with the Guild Statute Book Project. At this stage, the project is still in a collection phase and a completion date cannot be accurately set. It should be noted that the policy book to which I refer is different from the document currently termed the policy book.

PROJECT STATUS - **ONGOING**

Determinations regarding the Guild Regulation

The Governance Committee has, at this stage, made 4 determinations in reference to the Guild Regulations, listed below:

- All references in the UWA Guild Regulations to the "statues committee" refer to the "governance committee" as defined in 6.11 of the UWA Student Guild Regulations
- Where Regulation 6.1.8 states "total members of that guild committee" it refers to the "total current voting membership of the guild committee"
- In Regulation 26.1.10 the right to move motions includes the right to both propose and second motions
- The Immediate Past President shall have all powers listed in regulations 26.1.10, regardless of regulation 26.1.11
