#### 3.0 MOTIONS ON NOTICE

3.1 The 105th Guild Council accepts the attached Guild Election Regulations as approved by the Governance Committee.

Moved: Molly Goldacre; Seconded: Benjamin Perry

Molly says that these regulations have been unanimously passed on the Governance Committee and has been approved by the Guild's lawyers. Molly explains that election broadsheets are being removed because they a waste of time, money and they are not read. Molly says that in terms of regulation 611, it has been amended to align with the WAEC as the Guild's electoral regulations need to follow the WAEC.

Molly says that the change of 613(3) has been made due to recommendation from the Returning Officer for administrative purposes and so that undue stress isn't placed on the returning officer. Molly says that Regulatin 614, makes Council Transition Training becomes mandatory is an important part to ensure people are running for the right reasons and by having it on the nomination forms increases the level of commitment from the beginning. The personal delivery of the nomination form ensures that people are willing to put in the effort if the person is elected to Guild Council. The deposit for running will also be lodged at the same time of form delivery according to the changes to 614(9). Molly says that Guild Council will also have control over the location of roaming booths or 'special polling places' so that there is more flexibility in this process.

Molly says that Regulation 622(3) reduces the printing cap from 12,600 to 6000. Molly says that 622(A) addresses the issue of externally hosted websites being used within a campaign. It ensures that the websites are being compliant with the electoral regulations.

Molly says that she has been in consultation with the Guild lawyers and that this change will be okay and allowed to occur.
