12. MOTIONS ON NOTICE (REPRESENTATION)

- 12.1 The 108th Guild Council:

- 12.1.1 Stands with and believes survivors of sexual assault.
12.1.2 Recognises the ongoing crisis of sexual assault across Australian Institutions
12.1.3 Calls on the State Government to implement compulsory and standardised consent training across Australian educational institutions from Year 7 or earlier.
12.1.4 Encourages the UWA Community to sign the Change.org petition for consent education in WA Schools.
12.1.5 Directs the Guild President to send a letter of support to the Minister for Education, Minister for Women's Interests, and the Premier concerning sex education in schools.

- 12.2 The 108th Guild Council:

- 12.2.1 Supports the Deaths in Custody protest held in Perth this month, which stood strongly against the Australian police and the legal system designed to protect them - evident in the fact that from at least 474 deaths of Indigenous people in police custody since 1991, not a single police officer has been convicted.
12.2.2 Acknowledges and condemns that in the 30 years since the Deaths in Custody Royal Commission, the Australian Government has not followed through with their commitments to the commission recommendations.
12.2.3 Opposes the institution of the police, which since its inception has operated to protect the interests of those in power, including by criminalising and punishing poverty, violently oppressing Indigenous people and people of colour in Australia and internationally, and repressing protests and strikes
12.2.4 Sees the struggle against racist policing as a global one - the continued disproportionate rate of Black deaths in custody here is mirrored by the police



- killings of people of colour and deaths in custody in the US, for which police are rarely convicted.
- 12.2.5 Extends solidarity to the protestors in the Black Lives Matter movement in the US, which has reignited in response to multiple murders of people of colour by police during the trial of Derek Chauvin.

- 12.3 The 108th Guild Council:
- 12.3.1 Endorses the climate strike on May 21 called by School Strike 4 Climate, which calls to #FundOurFutureNotGas
- 12.3.2 Opposes the Liberal and Labor parties' commitment to expanding coal mining and gas fracking in Australia, particularly in WA, which was recently reaffirmed by Labor MP Madeleine King stating that Australia will continue to mine and export coal so long as there is demand for it, regardless of environmental concerns.
- 12.3.3 Sees that as representing the total inadequacy of a market-based approach to climate action, as politicians are unwilling to take any action which compromises the profits of the fossil fuel industry.
- 12.3.4 Recognises the imperative for UWA students in particular to attend the strike, given the active role our university takes in developing the fossil fuel industry in WA, and commits to building a university student contingent to the strike to challenge the university's commitment to fossil fuel funding and research.

- 12.4.2 The 108th Guild Council recognizes the staff Climate Change Community of Practice and supports their work in building the climate community amongst staff at UWA, and it's participation in the Collegial Conversation - to be held on July 27th.
- 12.4.3 Condone the hosting of the Big Student Climate Forum on May 6th, 2021 as an avenue for students and student-societies to express their foremost concerns & ideas surrounding UWA's action on climate change.
